

K-LIFE Extended Hands Scholarship Fund Application

Last Update: June 9, 2019

Selection Criteria

Scholarship awards serve two equally valuable purposes: recognition of merit and achievement, as well as provision of financial support. The allocation of scholarship funds will be balanced between awards to applying students and awards to students already in a program. For students already in a program, scholarship funds are more likely to recognize concrete achievements during a student's career at their school of choice and may also permit students to continue at the University/College when their financial resources might not otherwise permit them to do so.

Former Winner Applicant(s) <u>may not</u> be considered for a scholarship if they were the winner of a scholarship in the previous school year; in other words, winning the scholarship back to back years. However, they are eligible to receive a bursary of a lesser amount.

In recognition of the criteria specified in the KLM Scholarship Fund we seek to award the scholarship funds to ensure that the entire items are recognized in the aggregate pool of scholarship recipients:

As a general rule, our expectation is that students receiving scholarships should display **two or more** of the below attributes, with exception to **Attribute #1** (**MANDATORY**):

1. Kingdom Life Member

Kingdom Life Ministries has positioned itself as a leader within the category of "Excellence and Leadership" in the arena of changing people's life by the awesome power and gifting of the Holy Spirit. All applicant(s) MUST be active members of this body of Christ and support the visions and goals of Kingdom Life Ministries, the scholarships awarded annually will reflect broadly on our identity as leaders in the community and various church organizations.

2. Academic Merit

For applying students (1st year), academic merit traditionally means that students rank at the top of their graduating class and will need to submit their transcript for verification and authentication. For continuing students, we consider an average of at least 80 %, course selection, credit load (12 credits minimum), and undergraduate research experience. Students should also be actively involved in extracurricular activities.

3. Creative Accomplishment

Students must demonstrate originality and innovation in the arts and humanities, sciences, or social sciences. The selection committee considers the accomplishments of writers, artists, and musicians just as seriously as scientists.

4. Financial Need

The committee considers how students are financing their education. Students applying for scholarships based on financial need should clearly state in their application how many hours per week they work.

5. Unusual Force of Character

Students who have overcome obstacles related to health, family, social, educational or economic disadvantages are encouraged to apply. Any circumstance that shows strength of character and potential for achievement should be stated in your application.

6. Community Service

The committee considers not simply your community service but, more importantly, the impact your service has had on a particular individual or group. The committee considers volunteerism, service learning, field-work or internships that show civic responsibility and engagement.

7. Leadership

Students who demonstrate experience leading groups and providing direction to others including teaching, training, organizing, managing and carrying more responsibility on the part of a group or organization. Being held in high regard by one's peers for being a role model through actions and deeds; and making improvements and achieving successes with or on behalf of others.

POLICIES:

- The committee members can make a unanimous decision to select only one award winner in any given year. However, it is hoped that (1-2) scholarships will be awarded annually, amount to be made public at time of recipient being awarded. The scholarships will be awarded prior to the start of the school semester.
- The scholarship funds may be made payable to the name of the post secondary institution e.g. College or University that the winner is attending the start of the school semester. In this event, funds would not be made payable to the name of the scholarship winner.
- If the student has received the scholarship and, without reason, decides not to study as planned, the scholarship must be returned in full. If time allows, the next applicant in line may then be given the scholarship.
- If the student should fall ill and cannot attend school all efforts should be made by the student to obtain a refund and return the unused portion, if any to KLM.

HOW TO APPLY:

- All applicants must provide the following documents prior to being eligible for scholarship consideration:
 - High school transcripts or
 - Current post-secondary transcript
 - Acceptance letter for school of choice
 - Written intent from applicant of accepting/enrolling at desired school
 - Recent Photo (headshot)
 - All applicants must submit a short 500-word essay explaining clearly why they are the best candidate for the scholarship. Explain your involvement with KLM and how long you have been a member. Express your opinion on 2 or more of the above attributes.
 - You may be asked to attend an interview with the selection committee
 - Submission date to be established year to year
 - Completed application from part 1 and 2
- All application forms are subject to Pastor's approval.

SELECTION COMMITTEE GUIDELINES:

SCHOLARLY COMPETENCE

1. Review the individual's GPA, but also place emphasis on the type of classes and the thought that the student displays. How has work or life experiences contributed to making this candidate a potential scholarship winner.

APPROPRIATENESS TO THE TIME

2. Are the timelines (goals), course selections, of the applicant in line with the timing of the scholarship?

QUALITY OF APPLICATION

- 3. Is the essay well written and clearly meet all the criteria set out in the policy? Does it really convince you that the applicant really wants to learn and study?
- 4. No selection committee member can vote/offer opinions on applicants who are children, Godchildren, other immediate family members (1st or 2nd cousin's nieces/nephews) but not limited to only these. It is expected that committee members will withdraw from input in these cases.
- 5. 1st round of the application process will be blind. All application will be reviewed and voted on in and placed in 1 of 3 categories:
 - a. Under consideration (Yes)
 - b. Not viable (No)
 - c. Unsure (Discussion required by members)
- 6. 2^{nd} round all "Unsure" will be reviewed by all members and will be agreed to remain in same spot or move to either (**A**) or (**B**).
- 7. 3rd round all committee members will select 2 candidates to argue for awarding of the scholarship.
- 8. 4th round each member will give a rating number for each of the following categories: *a score of 1 is high and a score of 4 will be considered low.*
 - a. Course selection
 - b. GPA
 - c. Strength of essay
 - d. Financial aid component/necessary
 - e. Active member of KLM
- 9. Final decision must be made at least 1-2 weeks in advance of announcement date. Scholarship recipient (s) will be chosen by the date set by the committee at the time of the program launch
 - o You may be asked to attend an interview with the selection committee

- Applications must be submitted by the deadline date communicated via the church weekly announcement; late applications will not be accepted.
